South to Hotel

Merge onto US-13 N via Exit 282 towards Chesapeake Bay Bridge-Tunnel (Portions toll)

US-13 N becomes Charles M. Lankford Jr Memorial Hwy (Crossing into Maryland)

Charles M. Lankford Jr Memorial HWY becomes US-13 N

Merge on US-13 N towards Dover/Centre Road (Crossing into Delaware)

Take the SR-1 ramp toward I-95/Wilmington/DEL. MEM. BR.

Merge onto DE-1 N (Portions toll)

Keep Left at the fork to continue on DE-1 N (Portions toll)

Stay straight to go onto S DuPont HWY/US-13N

Stay straight to go onto S DuPont HWY-US-13 N. Continue to follow US-13N

Turn slight left onto US-301 N/N DuPont HWY/US-13 N/US 40 E

1612 N DuPont HWY is on the Right.

North to Hotel

Merge onto I-95 via the exit on the Left towards Chester/Phila Int'L Airport

Merge onto L-495 S Via Exit 11 towards Port of Wilmington/Baltimore (Crossing into Delaware)

Merge onto N DuPont HWY/US-13 S via Exit 1 toward US-13 40/Dover/Wilmington

Make a U-Turn onto N. DuPont HWY/US-301 N/US-13 N/US-40E

1612 N DuPont HWY is on the Right

West to Hotel

Start out going East on Constitution Ave NW-US-50 toward 15th ST NW

Turn Right onto 9th St NW

Merge onto 1-395 N via the ramp on the left toward I-295

Keep Left to take I-295 S

Keep Left to take Southwest FWY toward Pennsylvania Ave

Merge onto Pennsylvania Ave SE

Merge onto DC-295 N via the ramp on the left (Crossing into Maryland)

Merge onto I-895 N/Harbor Tunnel Trwy (portions toll)

I-895 N/Harbor Tunnel Trwy becomes I-95 N (portions toll)

Crossing into Delaware

Merge onto I-295 N towards New Jersey Turnpike/DEL Mem Br/NJ\NY

Merge onto N DuPont Hwy\Us-13 N via the exit on the Left toward Wilmington
